## Gift Aid

If you are a UK taxpayer we can claim the basic rate of tax you have paid, at no cost to yourself. This means that for every £1 you donate, we can claim an extra 25 pence. This makes a huge difference. Higher-rate taxpayers can claim further tax relief in their self-assessment forms.

1. If your declaration covers any donations you may make in the future, please inform us if you change your name or address while the declaration is still in force. You can cancel the declaration at any time by notifying 'WaveLength' –it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
2. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that our charity reclaims on your donations in the tax year (currently 20% for each £1 you give).

I want you 'WaveLength' to treat all donations I make from the date of this declaration, until I notify you as otherwise, as Gift Aid.

3. If in future your circumstances change and you no longer pay tax on your income and capital gains at least equal to the tax our charity reclaims, you can cancel your declaration.
4. If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
5. If you are unsure whether your donations qualify for Gift Aid tax relief, ask us. Or you can ask your local tax office for leaflet IR113 Gift Aid.
